

PEARL RIVER COUNTY BOARD OF REALTORS®

I hereby apply for REALTOR® Membership in the Pearl River County Board of REALTORS® and MLS, enclosing payment in the amount of \$400.00 for a one time application fee to the Board, a onetime application fee of \$250.00 for the (MLS), a one time Orientation fee of \$75.00, a deposit of \$25.00 for the Sentricard, and \$ for my dues payable to the Pearl River County Board of REALTORS®, as well as State and National dues (please see fee schedule and insert correct amount(s)).

I understand that my dues will be returned to me in the event of non-election and that the application fee is nonrefundable. I will attend orientation within **90-days** of Association's confirmation of membership (if applicable). Failure to meet this requirement may result in having my membership terminated. In the event of my election, I agree to abide by the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS®, which includes the duty to mediate and arbitrate and the Constitution, Bylaws and Rules and Regulations of the above named Association, the State Association and the National Association, and if required, I further agree to satisfactorily complete a reasonable and non-discriminatory written examination on such Code, Constitutions, Bylaws and Rules and Regulations. I understand membership brings certain privileges and obligations that require compliance. Membership is final only upon approval by the Board of Directors and may be revoked should completion of requirements, such as orientation, not be completed within timeframe established in the association's bylaws. I understand that I will be required to complete periodic Code of Ethics training as specified in the association's bylaws as a continued condition of membership.

NOTE: Applicant acknowledges that if accepted as a member and he/she subsequently resigns from the Association or otherwise causes membership to terminate with an ethics complaint pending, the Board of Directors may condition renewal of membership upon applicant's certification that he/she will submit to the pending ethics proceeding and will abide by the decision of the hearing panel. If applicant resigns or otherwise causes membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while applicant was a REALTOR®.
